Although interpretations rely upon the statement actually delivered, copies of texts help interpreters to correctly render details and nuances. Speakers are therefore encouraged, whenever possible, to provide copies of their statements, as early as possible in advance of delivery, to the Conference Officer in the World Forum Theatre.

Delegations are kindly requested to make 20 copies for minimum distribution to the podium and relevant services, and 250 additional copies for general distribution in the World Forum Theatre.

Delegations are also invited to send by e-mail an electronic copy of their statement(s), in one or more of the six official languages, to ensure timely posting of the text on the Assembly web site and as a step to reducing paper usage. Statements should be sent to: asp@icc-cpi.int.

Furthermore, in accordance with the past practice of the Assembly, the States may wish to participate in the general debate by making written submissions, which would be posted on the website of the Assembly. President of the Assembly wishes to invite States in a position to do so to submit written statements only.
