

Victims of international crime



The Trust Fund for Victims is a monument to the global commitment made under the Rome Statute to support the rehabilitation of victims and their families. The establishment of the Trust Fund for Victims under the Rome Statute helps fulfill an international promise through voluntary contributions to support programmes which address the harm resulting from crimes under the jurisdiction of the International Criminal Court by assisting victims to return to a dignified and contributory life within their communities. The vision of the Trust Fund for Victims is ensuring empowerment, hope, and dignity for victims of war crimes, crimes against humanity, and genocide. The TFV develops physical rehabilitation, psychological rehabilitation, and material support initiatives with victims as partners.

The Trust Fund for Victims is governed by a Board of Directors chaired by Elisabeth Rehn of Finland. Members of the board include Betty Kaari Murungi of Kenya, Eduardo Pizarro-Leongómez of Colombia, Vaira Vike-Freiberga of Latvia, and Bulgaa Altangerel of Mongolia.

In addition to this broad range of engagements there are several different activities of CFPF utilizing the peacebuilding power of moving pictures, for example the implementation of a Film Catalogue for Schools, which was invented under the patronage of President Gorbachev, the annual presentation of the International Green Film Award by Leonardo DiCaprio and the set-up of an online platform for "green" movies. ICC Prosecutor Luis Moreno-Ocampo is a honorary patron at the annual Cinema for Peace gala in Berlin, presenting the Cinema for Peace Award for Justice.

security, developing friendly relations among nations and promoting social progress, better living standards and human rights. Due to its unique international character, and the powers vested in its founding Charter, the Organization can take action on a wide range of issues, and provide a forum for its 192 Member States to express their views, through the General Assembly, the Security Council, the Economic and Social Council and other bodies and committees. One of these is the development of international law, one example of which is the achievement of the Rome Statute for the International Criminal Court. ## CHILDREN OF WAR



"Children of War" by Bryan Single is a harrowing documentary which captures the story of a group of former LRA child soldiers in Northern Uganda as they undergo a process of emotional and spiritual healing in a rehabilitation centre. "Children

of War" reminds the world of the urgent need to implement the ICC decision to arrest Joseph Kony who is still at large. "Children of War" won the "CINEMA FOR PEACE Award for Justice 2010" presented by the Prosecutor of the ICC, Luis Moreno-Ocampo.

### THE SECRETARY-GENERAL



On 1 January 2007, Ban Ki-moon of the Republic of Korea became the eighth Secretary-General of the UNITED NA-

TIONS, bringing to his post 37 years of service both in Government and on the global stage. Mr. Ban has long-standing ties with the UNITED NATIONS. In 1999, he served as Chairman of the Preparatory Commission for the Comprehensive Nuclear Test Ban Treaty Organization. In 2001-2002, as Chef de Cabinet during the Republic of Korea's presidency of the General Assembly, he facilitated the prompt adoption of the first resolution of the session, condemning the terrorist attacks of 11 September. Mr. Ban has been the Vice-Chair of the South-North Joint Nuclear Control Commission following the adoption of the historic Joint Declaration on the Denuclearization of the Korean Peninsula. In September 2005, as Foreign Minister, he played a leading role in bringing about another landmark agreement aimed at promoting peace and stability on the Korean peninsula with the adoption at the six-party talks of the Joint Statement on resolving the North Korean nuclear issue.

# BENJAMIN FERENCZ



Benjamin Ferencz, born in 1920, was an investigator of Nazi war crimes after World War II and the Chief Prosecutor for the United States at the Einsatztruppen Trial at Nuremberg, Germany.

He has continuously been trying to stop the atrocities of war from happening again — by making war illegal, by making it a crime. Benjamin Ferencz spent most of his life working for world peace through the development of international law. His expertise helped shape the war crime tribunals for Yugoslavia and Rwanda. He has campaigned tirelessly for the creation of the International Criminal Court.
