

## DANIEL DAVID NTANDA NSEREKO

**PROFESSOR NSEREKO** is a citizen of Uganda. Currently a Visiting Scholar at the *Max-Planck Institute for Foreign and International Criminal Law* in Freiburg, Germany, he is an internationally recognized scholar of International Law, International Criminal Law, International Human Rights, and Criminal Law and Procedure. A holder of a doctorate in law from NYU, he has lectured in several countries and published extensively in internationally peer-refereed scholarly works on these subjects. He serves on the editorial boards of a number of international periodicals, such as the *Criminal Law Forum*, *Journal of Church and State*. He has also served as an expert consultant to the Chief Prosecutor of the International Criminal Court and to the International Criminal Tribunal for Rwanda and in that capacity rendered opinions on complex legal issues. He provided an expert legal opinion in a case pending before the African Commission on Human and People's Rights.

In September 2002 and January 2003 he served on the Uganda Government Delegation to the first session of the Assembly of States Parties to the Rome Statute of the International Criminal Court in New York. In June 2004 and June 2005 he served on the Uganda Government Delegation to the Inter-Sessional Meetings of the Special Working Group on the Crime of Aggression of the Assembly of States Parties to the Rome Statute, at Princeton, New Jersey. Between 1995 and 2002 he actively participated as an expert in most of the sessions of the PrepCom and the Rome Diplomatic Conference of Plenipotentiaries. He has also served on several international missions to investigate alleged violations of human rights and humanitarian law, to inspect prison conditions and to act as a trial observer. He has also served as a UN expert in criminal prevention and criminal justice, including the development of standards in the field.

A Professor of Law at the University of Botswana, Dr. Nsereko is also a member of the Advisory Committee of the War Crimes Research Office of the American University (USA), member of the International Advisory Board of the International Doctorate School of Excellence of the University Cologne (Germany) and a Visiting Scholar at the *Max-Planck Institute* (Germany). In 1982 he was a Fellow at the Institute of International Law and International Relations Research of the *Hague Academy of International Law*. In 1996 the *International Society for the Reform of Criminal Law* awarded him a Medal in recognition of his contribution to international human rights and criminal law reform.

An Advocate of the High Court of Uganda, Professor Nsereko possesses considerable practical experience as a trial lawyer, having practised law in Uganda. It was in recognition of this experience as well as his competence in international law and criminal law and procedure that the Registrar of the International Criminal Court added his name to the List of Counsel who are eligible to be appointed to represent the accused and victims before the Court.

He previously taught law at Makerere University in Uganda. Joining the University of Botswana in 1984, he served as the Head of its Law Department between 1984 and 1993.

Between 1993 and 1994 he served as the *Walter S.Owen Visiting Professor of Law* at Faculty of Law of the University of British Columbia in Vancouver, Canada. He has also at divers times lectured to graduate classes at the University of Cape Town in South Africa, University of Salzburg in Austria , University of Teramo in Italy and the Universities of Cologne and Göttingen in Germany.
