Overall objectives:

- Show videos of audio-visual programmes produced by PIDS and broadcast radio programmes;
- Publicise the judicial proceedings before the Court, and, in particular, provide updates in relation to: the trial of Katanga and Ngudjolo Chui; the decision by the Appeals Chamber in the case of Jean-Pierre Bemba concerning the Prosecutor's appeal against the decision granting interim release to Jean-Pierre Bemba; and, in the Lubanga case, a decision postponing the presentation of evidence by his Defence pending a decision from the Appeals Chamber on the legal characterisation of the facts.
- Prepare for President of the ICC's visit to the DRC.
