

ROUND-TABLE MEETING OF LEGAL EXPERTS ON THE FORTHCOMING REVIEW CONFERENCE OF THE ROME STATUTE OF THE INTERNATIONAL CRIMINAL COURT (DRAFT)

Jointly organized by the Governments of Malaysia, Japan and the AALCO to be held at The Attorney General's Chambers, Putrajaya, Malaysia, on 30th and 31st March 2010

Objective:

The first Review Conference of the treaty establishing the ICC- the Rome Statute of the International Criminal Court is scheduled to take place in Kampala, Uganda from 31 May to 11 June 2010. The Draft Provisional Agenda of the Review Conference includes:

- Consideration of the progress of international criminal justice
- Consideration of proposals for the amendment of Rome Statute:
 - (a) Review of article 124 of the Rome Statute;
 - (b) Proposals for a provision on the crime of aggression
 - (c) Other Proposals

The **objective** of the proposed Round Table Meeting is to enable the AALCO Member States and other ASEAN Member States to deliberate upon the substantive issues before the forthcoming Review Conference.

The **methodology** at the Round Table would be to discuss in-depth the issues to be tabled before the Review Conference. This would enable the Member States participating in the Meeting to coordinate and understand each other's position on the critical issues before the Review Conference. In view of this, the agenda of the Round Table Meeting has been modeled on the basis of the agenda of the Kampala Review Conference. The outcome document expected to be adopted on the concluding-day of the Round-Table would be reflective of the participating States and would be placed before the Review Conference as an AALCO document.

Therefore, in order to promote a vibrant discussion the AALCO Member States and other ASEAN Member States are requested to nominate Legal Experts / Delegates expected to represent their respective Governments at the forthcoming Review Conference to participate in this two-day Round-Table Meeting. The Airfare and the accommodation costs would be borne by the participants themselves.
