# Ninth Diplomatic Briefing of the International Criminal Court

The Hague, 29 March 2007

Information Package (As of 15 March 2007)

Summary of activities since the Fifth Session of the Assembly of States Parties 23 November - 1 December 2006, The Hague

At the end of January, a Pre-Trial Chamber confirmed charges of war crimes against Mr. Thomas Lubanga Dyilo in relation to the situation in the Democratic Republic of the Congo. Should the Appeals Chamber uphold the confirmation of charges, the Court's first trial is expected to start this year. In February, the Prosecutor requested the judges to issue a summons for two persons, Mr. Ahmad Muhammad Harun and Mr. Ali Muhammad Ali Abd-Al-Rahman, to appear before the Court in connection with alleged war crimes and crimes against humanity in relation to the situation in Sudan. The arrest warrants issued by the Court in the situation in Northern Uganda for five members of the Lord's Resistance Army (LRA), including its leader Joseph Kony, remain outstanding. One of the five individuals has been killed. The other four are at large.

With the support and cooperation of States, the Court will continue to make progress in its judicial activities. The Court has entered into agreements on relocation of witnesses and, in one case, enforcement of sentences. The Court has also made specific requests for cooperation in connection with the current situations on a number of instances. States have taken their own steps to cooperate with the Court, including adopting implementing legislation to comply with their obligation to cooperate under Part 9 of the Rome Statute, and ratifying the Agreement on the Privileges and Immunities of the Court in order for the Court to be able to carry out its functions unimpeded on their territories and to allow the travel of victims and witnesses through their territories to the Court.

The focus of the presentations in the ninth diplomatic briefing will be on elaborating the types of cooperation needed by the Court. The President, Prosecutor and Registrar will provide additional indications of specific forms of cooperation required and current efforts underway to articulate the Court's needs most effectively.

### **Presidency and Chambers**

### I. <u>Presidency</u>

- ➤ Issued a Decision on 6 March constituting Trial Chamber I, which will be composed of judges Elizabeth Odio Benito, René Blattmann, and Adrian Fulford. The case of *The Prosecutor v Thomas Lubanga Dyilo* has been referred to the new Trial Chamber.
- > Travelled to a number of countries not party to the Statute including Chile, Guatemala, Japan, Turkey and Ukraine.
- ➤ Together with the Prosecutor and Registrar, briefed the Permanent Representatives Committee of the African Union in Addis Ababa on 1 March 2007.
- ➤ Met with representatives of States, international organisations, and nongovernmental organisations at the Court.

### Other Major Activities Planned

Continued coordination on implementation of the strategic plan.

### II. Chambers

Held hearings and issued decisions at the Pre-Trial and Appeals level on such matters as:

### Democratic Republic of the Congo

### > Pre-Trial Chamber

- 29 January 2007 Confirmed three charges against Thomas Lubanga Dyilo of the war
  crimes of enlisting and conscripting children under the age of fifteen and using them to
  participate actively in hostilities. The Chamber committed him for trial.
- 14 February 2007 Conducted a periodic review of the decision not to grant Mr. Lubanga interim release and decided that the Court should continue to detain him, pending trial.
- Decisions on a number of procedural issues including confidentiality of material and disclosure of documents.

# > Appeals Chamber

- 14 December 2006 Dismissed appeal brought by Mr. Lubanga challenging the jurisdiction of the Court.
- **14 December 2006** Reversed a decision and partially reversed another decision of a Pre-Trial Chamber, relating to restrictions on the disclosure of evidence and the identities of witnesses to the defence prior to the confirmation of charges hearing.
- 13 February 2007 Dismissed appeal brought by Mr. Lubanga against the decision to deny him interim release.
- Decisions on a number of procedural issues including the participation of victims in proceedings.

### Uganda

### ➤ Pre-Trial Chamber

• Decisions on a number of procedural issues including the participation of victims in proceedings and disclosure of documents and holding hearings *in camera* and *ex parte*.

# Central African Republic

### > Pre-Trial Chamber

 30 November 2006 – Requested that the Prosecutor provide a report on the preliminary examination of the Central African Republic situation to both the Chamber and the Government of the Central African Republic, including an estimate of when the preliminary examination will be concluded.

### Darfur, Sudan

### ➤ Pre-Trial Chamber

- 22 November 2006 Dismissed a Defence challenge to admissibility and jurisdiction
- Decisions on a number of procedural issues including requests for leave to appeal, requests for leave to file documents and holding hearings ex parte.

### Office of the Prosecutor

### Uganda Investigation

- Responded on 8 December to a request of Pre-Trial Chamber II for additional information on the status of the execution of the warrants of arrest.
- Prepared evidence to ensure its continued readiness for a confirmation hearing.
- Participated in two outreach missions prepared by Registry and with the assistance of partner organisations.
- Met with Mr. Chissano, former President of Mozambique and current Special Envoy of the UN for LRA Affected Areas.
- Continued to galvanize efforts to support the territorial State in arresting the remaining LRA commanders.

# Darfur Investigation

- Reported on 14 December 2006 to the Security Council on the status of the Darfur Situation in accordance with Resolution 1593.
- Continued investigation into the situation in Darfur, Sudan, conducting during the course of the investigation over 70 missions in 17 countries, taking statements from more than 100 witnesses, many of them from victims, and collecting thousands of documents.
- Conducted the Office's 5th mission to Sudan in January-February 2007.
- Submitted a filing to Pre-Trial Chamber I on 27 February 2007 requesting summonses to appear against Ahmad Muhammad Harun and Ali Kushayb in relation to 51 counts of war crimes and crimes against humanity.
- Briefed countries of the region, the African Union and the Arab League, including meeting with the Foreign Minister of Ghana, as the Presidency of the AU, and the Secretary General of the Arab League.
- Took measures to manage security concerns of ICC field presence.
- Continued to assess witness security in coordination with Registry.
- Continued to develop outreach strategy for Darfur in collaboration with the Registry.

### Democratic Republic of the Congo Investigation

- Completed the investigation of the first case against Thomas Lubanga Dyilo, on charges of enlisting, conscripting and using children under the age of 15 years to participate actively in hostilities.
- Participated in first ever confirmation hearing before the ICC, from 9 November 2006 to 28 November 2006, which led to the confirmation of charges by Pre-Trial Chamber I on 29 January 2007.
- Requested on 5 February 2007 Pre-Trial Chamber I to grant leave to appeal one aspect of its Decision on the Confirmation of the Charges.
- Continued preparation for the trial of Thomas Lubanga Dyilo.
- Continued to investigate a second case concerning crimes allegedly committed by another Ituri armed group.
- Continued the process of selecting a third case to investigate in the DRC.

### Analysis

- Continued analysis of five situations including the Central African Republic and Côte d'Ivoire.
- The Office has renewed its request for an assessment mission in Côte d'Ivoire but the Ivorian authorities have not yet responded.
- Refinement of OTP policy papers on case and situation selection and gravity and interests of justice.
- Received and analysed 120 Article 15 communications between 1 December and 15 March.

### Cooperation

- Submitted approximately 20 requests for cooperation to States and international organizations.
- Conducted ongoing negotiations with a number of information providers with a view to concluding cooperation arrangements.
- Continued to process all disclosure matters related to article 54(3)(e) and associated interaction with information providers.

#### Other Activities

- Briefed the Friends of the ICC in New York on 15 December 2006 and 5 March 2007 and in The Hague on 9 March 2007.
- Briefed the Permanent Representatives Committee of the African Union in Addis Ababa on 1 March 2007.
- Briefed the Cojur in Brussels on 1 March 2007.
- Met with representatives of States, international organisations, and nongovernmental organisations at the Court.
- Prepared the NGO-OTP Roundtable to be held 28-29 March.

### 1. Division of Common Administrative Services

- ➤ Conducted the first fully electronically managed hearing confirmation of charges.
- Provided remote access including the possibility for disclosure to Defense Counsel.
- > By concluding the Memorandum of Understanding with the United Nations (DPKO), significant progress has been made in communication with field offices via satellite hub located at the UN Logistics Base in Brindisi (UNLB).
- ➤ Participated in a UN led SAP-International Public Sector Accounting Standards (IPAS) working group, to prepare the integration of new accounting standards for the Court.
- ➤ Coordinated minimization of ICC field presence in Chad (Abeche) and in the DRC (Kinshasa) as a consequence of high security risk situation.
- ➤ Implemented a system of emergency medical evacuation for staff operating in the field.
- > Continued negotiations with host State on additional office space. The current forecast shows that the Court will run out of office space by April 2007. This forecast includes the occupancy of a third floor added in January to the current interim premises (i.e. the "Hoftoren" building)
- > Set-up initial operational processes for cooperation with the Special Court for Sierra Leone.

# 2. Division of Court Services

- ➤ Implementation of the ICRC's recommendations following its second visit to the ICC's detention centre (19 and 20 September 2006) is in progress.
- Organised family visits for detained persons at Scheveningen prison complex.
- First release of the Terminology Bulletin in 7 languages (Acholi, Arabic, English, French, Russian, Spanish, Swahili) on Names of Countries and Acronyms related to the Democratic Republic of the Congo.
- > 729 filings registered (both originals and translations), 3498 pages of transcript (French and English together), 115 evidence presented in Court.
- ➤ 600% increase in the referrals to the Court related to witness protection.

### 3. Division of Victims and Counsels

- List of counsel eligible for appointment to accused and victims contains 198 counsel to date.
- ➤ Provided assistance to the defence team of Mr. Thomas Lubanga Dyilo, and to Mr. Lubanga in particular with respect to the appointment of a new defence counsel.
- ➤ Provided assistance to the ad hoc counsel appointed to represent and protect the general interests of the defence situations in Darfur (Mr. Hadi Shalluf) and Uganda (Ms. Michelyne St-Laurent).
- First decision on legal assistance paid by the Court for a legal representative of a victim, to participate in the confirmation of charges hearing in the Lubanga case.
- Provided support, assistance and information to legal representatives of victims during the confirmation of charges hearing, including ensuring installation and training as regards in-court applications and other software provided for their use in relation to the proceedings.
- ➤ Received and processed 155 applications for victims' participation in the proceedings in relation to the situations (since November 2006).

### 3. Public Information and Documentation Section

- ➤ 12th and 13th ICC Newsletters were published and disseminated.
- ➤ During the reporting period 630.847 visitors accessed the ICC website (22.2% increase compared to the same period of last year) and 1,922 visitors attended briefing at the Court (4.4% increase).
- ➤ Reorganized Section establishment of the Outreach Unit.

# 4. Immediate Office of the Registrar

- Conducted workshops on the Strategic Plan involving more than 300 staff members in 15 different sessions.
- ➤ Compiled the functional brief (user requirements of the Court in respect to permanent premises).
- ➤ Field missions of the Registrar to Uganda (26 28 February 2007) and the DRC (6-13 March 2007).
- Future activities: Expert meeting on permanent premises 28 to 30 March 2007.

### 5. Office of Public Counsel for Victims

- ➤ Developed a legal database and library containing 300 materials for the use of staff and of legal representatives.
- ➤ Provided 30 legal advices and researches to legal representatives in the DRC situation, Lubanga case including the confirmation of charges hearing and the Darfur, Sudan situation.
- ➤ Following the decision of the Single Judge of the Pre-Trial Chamber II dated 1st February 2007, the Office is providing legal assistance to the 49 persons who applied to participate in the situation in Uganda and in the case against Kony and others.

### 6. Office of Public Counsel for Defence

- ➤ Mr Xavier-Jean Keïta took up office as Principal Counsel in January 2007.
- ➤ Provided assistance to defence counsel in three situations and two cases.

### **Update on Outreach Activities**

### Democratic Republic of Congo

Publicised the confirmation of charges hearing in the case *Prosecutor v. Thomas Lubanga Dyilo*:

- ➤ Published press releases, background information in the main newspapers in Kinshasa, 8 and 9 November 2006.
- ➤ 4 Congolese journalists sponsored by the Court reported from the HQ.
- ➤ Court officials interviewed by various radio stations from Bunia and Kinshasa.
- > RTNC national television station broadcasted, using the Court's satellite transmission, relevant moments of the hearing including opening remarks, witness examination, and closing remarks

- ➤ Informational meeting involving 55 demobilised children organised by ASAPI and CONADER, Bunia, Ituri, 30 January 2007.
- ➤ ICC informational meeting for 47 students and teachers, Bunia, Ituri, 31 January 2007.
- ➤ Participated in informative meetings with UNHCHR, Kinshasa on 6 and 16 February 2007.
- ➤ ICC Informational meeting involving 300 students and professors of *Université protestante du Congo*, Kinshasa, 8 February 2007.
- ➤ Informational meetings conducted by the Registrar involving religious leaders, NGOs, national and international humanitarian organisations, local judicial authorities, Bunia, Ituri, 8-9 March.
- ➤ Participation of the Registrar and Deputy Prosecutor to a public event by Interactive Radio for Justice involving over 300 participants, Bunia, Ituri, 9 March 2007.
- ➤ Participation of ICC officials in 4 radio programmes broadcasted by Radio Okapi on 29 January, 14, 19 February and 8 March 2007 and in 2 radio interactive programme (Lingala) on 16 and 26 February 2007.

# Darfur

- Partially translated relevant information available on the ICC website into Arabic.
- ➤ Satellite transmission of the press conference by the Prosecutor, live video streaming and distribution of relevant materials were organised on 27 February in relation to the Prosecutor's filing Darfur/Sudan.
- > *Future activities:* recruitment of the outreach field staff assigned to the situation in Darfur will start in April 2007.

### Secretariat, Assembly of States Parties

Recent ratifications of the Agreement on the Privileges and Immunities of the Court: Argentina and the Ukraine.

# I. <u>Sixth session of the Assembly</u>

- ➤ Invitations to the sixth session and the resumed sixth session of the Assembly were sent to all States in March 2007.¹ The sixth session shall take place at United Nations Headquarters in New York from 30 November to 14 December 2007. The specific dates for the resumed sixth session, scheduled to take place in New York during the first semester of 2008, will be communicated at a later stage.
- > On 9 March 2007, the Bureau of the Assembly agreed to include in the provisional agenda of the sixth session an item entitled 'General debate' and to invite Ministers of States to participate therein. The Bureau also agreed to consider at the sixth session the election of the President of the Assembly of States Parties for the seventh, eighth and ninth sessions of the Assembly.

### II. Resumed fifth session of the Assembly

- ➤ At its resumed fifth session, held at United Nations Headquarters in New York from 29 January to 1 February 2007, the Assembly elected Mr. Bulgaa Altangerel (Mongolia) as the fifth member of the Board of Directors of the Trust Fund for Victims.
- ➤ The Assembly adopted resolution ICC-ASP/5/Res.5 which amends the procedure for the nomination and election of judges in the event of a judicial vacancy.
  - As regards the judicial vacancy arising from the resignation of judge Maureen Harding Clark (Ireland), the Assembly decided that the election would be held during the sixth session of the Assembly. The Assembly fixed the nomination period to run from 1 June to 24 August.<sup>2</sup>
- ➤ In addition, the Assembly adopted resolution ICC-ASP/5/Res.6, amending the pension scheme regulations for judges (ICC-ASP/5/Res.3).

The Special Working Group on the Crime of Aggression focused on the definition of the crime of aggression and the conditions for the exercise of jurisdiction by the Court.

➤ The fourth inter-sessional meeting of the Special Working Group on the Crime of Aggression will take place from 11 - 14 June 2007 at the Liechtenstein Institute on Self Determination at the Woodrow Wilson School, University of Princeton, New Jersey.<sup>34</sup>

- ➤ On 9 March 2007, the Bureau approved the appointment of Mr. Marko Rakovec (Slovenia) as facilitator for the issue of arrears.<sup>5</sup>

# IV. The Hague Working Group of the Bureau

- ➤ The Working Group will hold a meeting of experts on the issue of permanent premises from 28 to 30 March 2007. Documentation was sent to States Parties via e-mail on 9 March 2007.
- Immediately after the end of the ninth Diplomatic Briefing organized by the Court, on Thursday, 29 March 2007, from 16.30 18.00 hours, The Hague Working Group will hold a briefing for Embassies based in Brussels. The objective is to provide interested Embassies with information on the programme of work for 2007 and on issues under consideration by the Working Group.

# V. <u>Committee on Budget and Finance</u>

➤ The nomination period for the election of six members of the Committee, scheduled to take place during the sixth session of the Assembly, runs from 1 June to 24 August 2007.6
