# Situation in Darfur, Sudan

In the situation in Darfur, Sudan, three cases are being heard: *The Prosecutor v. Ahmad Muhammad Harun ("Ahmad Harun") and Ali Muhammad Ali Abd-Al-Rahman ("Ali Kushayb"); The Prosecutor v. Omar Hassan Ahmad Al Bashir;* and *The Prosecutor v. Bahr Idriss Abu Garda*. Three warrants of arrest have been issued by Pre-Trial Chamber I for Harun, Kushayb and Al Bashir for crimes against humanity and war crime. The three suspects remain at large. A summons to appear was issued for Abu Garda who appeared voluntarily before the Chamber on 18 May 2009. Abu Garda is not in the custody of the ICC.

# Confirmation hearing in the Abu Garda case opened on Monday, in the presence of the suspect

On Monday, 19 October 2009, Pre-Trial Chamber opened the confirmation hearing in the case of *The Prosecutor v. Bahr Idriss Abu Garda*, in the presence of the suspect, who has not waived his right to be present at the hearing. According to the schedule adopted by the Chamber, the hearing will continue until 29 October, 2009. Abu Garda arrived voluntarily in The Netherlands on Saturday, 17 October, with enough time before the opening of the hearing to meet with his counsel.

The suspect had appeared voluntarily on 18 May, 2009, in compliance with a summons issued by Pre-Trial Chamber I. It was the first time that the International Criminal Court's (ICC) judges issued a summons to appear rather than a warrant of arrest. Pre-Trial Chamber I had considered that Abu Garda would appear before the Court and that his arrest was not necessary.


"The presence of Abu Garda at the confirmation of charges hearing shows his willingness to co-operate with the court", stated Ms Silvana Arbia, Court Registrar, during a press conference held on 16 October at the ICC headquarters in the presence of the two parties and other participants to the proceedings. The Registrar welcomed the co-operation of the Dutch authorities under the Headquarters Agreement with the Court, which has made it possible for the suspect to be present, under optimum conditions, both on his initial appearance and now at the confirmation hearing.

Abu Garda is the first suspect to appear before the ICC in the context of the situation in Darfur (Sudan), which was referred to the Court by resolution 1593 of the United Nations Security Council. He is suspected of three war crimes allegedly committed on 29 September, 2007, against the African Union peacekeeping mission in the Sudan: violence to life, in the form of murder, whether committed or attempted; intentionally directing attacks against personnel, installations, material, units, or vehicles involved in a peacekeeping mission; and pillaging.

"The peacekeepers were deployed to serve and protect civilians in Haskanita. Instead, they were murdered. The attack on Haskanita is one of many attacks against peacekeepers in Darfur, but it is the most violent incident. With the killings they had to withdraw, leaving thousands of civilians unprotected. The attack had consequences for the delivery of humanitarian aid as well as safety and security in the region. This cannot go unpunished", said Prosecutor Luis Moreno-Ocampo during the press conference.



# Judicial Update



Defence Counsel, Mr Karim Khan, explained, during the press conference that "the Defence is going to put our focus on testing what we say to be an unsatisfactory, incomplete and partial prosecution investigation".

The Legal Representatives of the 78 victims authorised to take part in the proceedings are able make opening and closing statements explaining their clients' personal interests in the case, and are entitled to intervene on issues of fact or law which could affect those interests.

During the press conference, Ms Hélène Cissé and Mr Akin Akinbote, legal representatives of African victims participating in this case, expressed the wish of their clients to have justice done and seen to be done, for this case to become a deterrent for belligerents not to attack peacekeeping mission members, and to ensure these members that they genuinely have the benefit of the protection given to them according to international law.

Pre-Trial Chamber I will have 60 days from the close of the confirmation hearing in which to render its decision. It may confirm the charges, wholly or in part, decline to confirm them, or adjourn the hearing and request the Prosecutor to provide further evidence, or to amend the charges. Both parties may seek leave from the Chamber to appeal against its decision.

If the charges are confirmed, and without prejudice to the issue of the suspect's guilt, which must be proved beyond all reasonable doubt, the case will be transferred to a Trial Chamber, which will conduct the trial phase of the proceedings.

## Situation in the Democratic Republic of the Congo

In this situation, three cases are being heard before the relevant Chambers: *The Prosecutor v. Thomas Lubanga Dyilo; The Prosecutor v. Bosco Ntaganda;* and *The Prosecutor v. Germain Katanga and Mathieu Ngudjolo Chui*. The accused Thomas Lubanga Dyilo, Germain Katanga and Mathieu Ngudjolo Chui are currently in the custody of the ICC. The suspect Bosco Ntaganda remains at large. The trial in the case *The Prosecutor v. Thomas Lubanga Dyilo* started on 26 January, 2009. The commencement of the trial in the case of *The Prosecutor v. Germain Katanga and Mathieu Ngudjolo Chui* is scheduled for 24 November, 2009.

# ICC Prosecutor confirms situation in Guinea under examination

In the wake of recent events in Guinea and in light of information related to the alleged commission of crimes under ICC jurisdiction, ICC Prosecutor Luis Moreno-Ocampo on 14 October confirmed that the situation in Guinea is under preliminary examination by his Office.

Guinea has been a State Party to the Rome Statute since 14 July 2003. As such the ICC has jurisdiction over war crimes, crimes against humanity or genocide possibly committed in the territory of Guinea or by nationals of Guinea, including killings of civilians and sexual violence. The Office of the Prosecutor has taken due note of serious allegations surrounding the events of 28 September 2009 in Conakry and has received information relating to these events in accordance with article 15 of the Rome Statute. A preliminary examination of the situation has been immediately initiated in order to determine whether crimes falling under the Court's jurisdiction have been perpetrated.

"From the information we have received, from the pictures I have seen, women were abused or otherwise brutalized on the pitch of Conraky's stadium, apparently by men in uniform" said Deputy Prosecutor Fatou Bensouda. "This is appalling, unacceptable. It must never happen again. Those responsible must be held accountable".

Other situations under preliminary examination by the Office include Afghanistan, Colombia, Côte d'Ivoire, Georgia, Kenya, and Palestine.

# ICC Prosecutor receives Palestinian Minister of Justice, Arab League and Independent Fact-Finding Committee

On 16 October, the Prosecutor of the International Criminal Court (ICC), Luis Moreno-Ocampo, received a Palestinian delegation headed by Dr. Ali Khashan, Minister of Justice of the Palestinian National Authority (PNA). Dr. Khashan was accompanied by the Palestinian Ambassador to the Netherlands, Nabil Abuznaid, and a team of legal experts including Vaughan Lowe QC, Professor of International Law at Oxford University. The Prosecutor also received members of the Independent Fact-finding Committee led by Professor John Dugard and members of the Arab League Secretariat, in the context of ongoing consultations.

The PNA delegation submitted a preliminary report presenting its legal arguments in support of the declaration lodged on 22 January 2009, accepting the jurisdiction of the Court over crimes committed in Palestine. The Office will carefully examine all supporting arguments submitted, starting with the initial issue of whether the declaration by the PNA accepting the exercise of jurisdiction by the ICC meets statutory requirements. The Prosecutor said "We appreciate the efforts undertaken by the PNA and the extensive legal arguments presented on a highly complex area of law."

A further report is to be presented by the PNA in the near future, clarifying additional issues discussed during the meeting.

Palestinian delegations *previously visited* the Court on 22 January and 13 February 2009.

## ICC Prosecutor and World Bank Vice-Presidency to Cooperate on Investigations

On 9 October 2009, International Criminal Court (ICC) Prosecutor Luis Moreno-Ocampo and Integrity Vice President of the World Bank Group (INT) Mr. Leonard McCarthy signed a Memorandum of Understanding in The Hague. The agreement will allow for cooperation on areas of common interest, such as the detection, substantiation and prevention of fraud and corruption in connection with conduct which constitutes a crime within the jurisdiction of the Court or which constitutes a serious crime under national law.

"The victims of crimes under ICC jurisdiction need justice and development. The International Criminal Court and the World Bank have different mandates, but a common interest to help these victims. We are exploring different ways of cooperation to serve them better," said the Prosecutor. "We are connecting our institutions to increase our efficiency. Crimes against the poorest should be punished."

Mr. McCarthy met with Prosecutor Moreno-Ocampo and members of the Prosecution and Investigation Divisions, and made a presentation to ICC staff on the work on institutional integrity within the World Bank. "*I am looking forward to working with the Prosecutor in areas of mutual interest,*" Mr. McCarthy said. "*We are two global institutions with global mandates, and we will be able to learn from each other.*"

# President Song addresses members of European Parliament and meets European Commissioner for Development and Humanitarian Aid

On Thursday 15 October, 2009, ICC President Judge Sang-Hyun Song was the key-note speaker at the Luncheon Conference on *The International Criminal Court (ICC) and the European Union - Challenges for the Promotion of International Justice and the Fight against Impunity,* held at the European Parliament in Brussels. On the same day President Song also met the European Commissioner for Development and Humanitarian Aid, Karel De Gucht.

At the Luncheon Conference, an interactive event organised by the European Parliament group of the NGO *Parliamentarians for Global Action* (PGA), President Song expressed his appreciation for the European Union's strong support of the Court. President Song discussed with members of the European Parliament how the Court and the EU can work together to address remaining challenges in the development of the Rome Statute system. In particular, the agenda included the impact of ICC cases and activity in situation countries; the European Union efforts in promoting the Rome Statute globally and its effective implementation in all European member states' legislation; the co-operation between the Court and the EU to enforce pending arrest warrants and support the mandate of the Court; and the first Review Conference of the Rome Statute.

Also in Brussels, President Song met the European Commissioner for Development and Humanitarian Aid, Karel De Gucht. Among the topics discussed were co-operation between the Directorate General for Development and the Court, the overall relationship between the EU and the Court, as well as preparations for the Review Conference to be held in Kampala, Uganda in 2010.





# Interacting with comunities

#### Outreach activities in the Central African Republic extend to Bossembele, Damara and Bossangoa

The Outreach Unit of the International Criminal Court went to meet with local administrative authorities in Bossembele on 8 October, Damara (in Ombella-Mpoko province) on 13 October and Bossangoa (in Ouham province) on 15 and 16 October in order to establish the basis of cooperation to hold future Outreach activities in their localities. The International Criminal Court is planning to organise information and Outreach sessions for these administrative authorities, as well as local authorities of these localities, before the end of the year.

This outreach campaign inside the country will continue during the first semester of 2010 with sessions organised for civil society organisations (NGOs, Women's groups etc.) and Youth representatives.

These Outreach activities will be based on a general presentation of the International Criminal Court and will be an opportunity to disseminate information related to judicial developments in the case *The Prosecutor v. Jean-Pierre Bemba Gombo*.

The cities of Bossembele, Damara and Bossangoa are all mentioned in the arrest warrant issued against Jean-Pierre Bemba Gombo. Some of the most serious crimes, falling under the jurisdiction of the Court, would have taken place in these localities between October 2002 and March 2003.
