Impact of the confirmation of charges in the Kenya situation

23-26 January - Following the Judges' decision to confirm charges in the Kenya situation against four accused, President Kibaki called on "everyone to remain calm and peaceful. Our great Nation has had its share of challenging times. On these occasions, we have re-examined our national conscience and moved forward together. We continue to do so. [...] It is now the collective responsibility of all these institutions to ensure justice for all at all times. [...] Today, we once again search our national conscience, re-dedicate ourselves to a true sense of national reconciliation and forgiveness. Let us move our country forward".

Kofi Annan, Chairman of the AU Panel of Eminent African Personalities, stated: "Justice should take its course. [...] The period leading to the next national elections will be challenging. As reforms continue and preparations for elections and devolution pick-up momentum, I urge all Kenyans to focus on these essential tasks. The Kenyans have the opportunity to lay a solid, democratic foundation for the future of their country, building on the spirit, letter and intent of the Constitution. The challenge now is to build a country that is peaceful and stable, to ensure sustainable development, rooted in respect for the rule of law and human rights."

The US State Department stressed that "accountability for the 2007-2008 post-election violence is critical to ensuring Kenya's democracy, peace, and long-term stability. [...] We urge the Kenyan government, the people of Kenya, and the individuals involved to continue to cooperate fully with the ICC proceedings and to remain focused on Kenya's future, especially through implementation of the reform agenda."

The EU High Representative for Foreign Affairs and Security Policy Catherine Ashton called on the four accused "to continue to cooperate fully with the ICC, and equally urges the Government of Kenya to respect its obligations as a State Party to the Rome Statute of the ICC".

On 26 January, following the ICC Judges' decision, President Kibaki accepted the decision by Mr. Kenyatta to step aside as the Minister for Finance, and the decision by Ambassador Francis Muthaura to step down from his position as Permanent Secretary, Secretary to the Cabinet and Head of the Public Service.

ICC judges in case against Katanga and Ngudjolo Chui visit Ituri

20 January - The judges of Trial Chamber II visited Ituri, in the east of the DRC. The Chamber, which is trying the case of *The Prosecutor v. Germain Katanga and Mathieu Ngudjolo Chui*, travelled to Bogoro, Aveba, Zumbe and Kambusto, visiting the scenes of the alleged crimes in this case and the home villages of the two accused and of a number of witnesses.

The Chamber decided it was necessary to visit these locations, together with the Prosecutor, the Defence and the Legal Representatives of the victims, in order to make its own findings and verify various witness accounts.

I. Preliminary Examinations

Preliminary examinations refer to the analytical process by which the OTP assesses whether there is a reasonable basis to proceed with an investigation in a given situation.

In accordance with Article 15 of the Statute, the OTP proactively gathers and evaluates information from multiple sources, including "communications" from individuals and parties concerned (phase1 – initial review). Following a sequential process, and irrespective of the mechanism by which the jurisdiction of the Court is triggered, the Office then applies the same legal criteria laid out in Article 53 of the Statute, namely temporal/territorial/personal jurisdiction (phase2), subject-matter jurisdiction (phase2), admissibility, including complementarity and gravity (phase3) and the interests of justice (phase4).

Currently, the OTP is conducting preliminary examinations into eight situations: <u>Palestine</u> (phase 2a), <u>Afghanistan</u>, <u>Honduras</u>, <u>Korea</u> and <u>Nigeria</u> (phase 2b), <u>Colombia</u>, <u>Georgia</u> and <u>Guinea</u> (Phase 3).

II. Investigations and Prosecutions

1. Situation in the <u>Democratic Republic of the Congo</u> (DRC) – Referred: April 2004 Investigation Opened: June 2004 Trials

The Prosecutor v <u>Thomas Lubanga Dyilo</u> – charged with war crimes against children committed in the Ituri region 2002 – 2003 **Status**: Trial finished on 26 August 2011, pending judgment

The Prosecutor v Germain Katanga and Mathieu Ngudjolo Chui – charged with war crimes and crimes against humanity committed during the attack of the village of Bogoro in the Ituri region on 24 February 2003

Status: Defence case presentation concluded, closing oral statements set to start on 15 May 2012

Confirmation of Charges Hearing

The Prosecutor v <u>Callixte Mbarushimana</u> – charged with war crimes and crimes against humanity, including massive sexual violence, committed in the North and South Kivus 2009 – 2010

Status: Pre-Trial Chamber I declines to confirm the charges (16 December 2011); OTP is seeking leave to appeal

Warrant Pending

The Prosecutor v <u>Bosco Ntaganda</u> – charged with war crimes against children committed in the Ituri region 2002-2003 **Issued:** 22 August 2006

2. Situation in <u>Uganda</u> – Referred: January 2004 Investigation opened: July 2004 Warrants Pending

The Prosecutor v <u>Joseph Kony</u> *et al.* – charged with war crimes and crimes against humanity committed during LRA's insurgency activities in Northern Uganda 2002 – 2004

Issued: 8 July 2005. On 11 July 2007, Pre-Trial Chamber I ordered to terminate the proceedings against <u>Raska Lukwiya</u>. On 8 November 2007, the OTP submitted information to the PTC on the reported death of Vincent <u>Otti</u>.

3. Situation in Darfur, the Sudan - Referred: March 2005 Investigation opened: June 2005

Trial

Warrants Pending

The Prosecutor v Omar Al Bashir – charged with war crimes, crimes against humanity and genocide committed as part of the counterinsurgency campaign in Darfur 2003 – 2008 (at least)

Issued: 4 March 2009 & 12 July 2010

The Prosecutor v <u>Ali Kushayb</u> and <u>Ahmad Harun</u> – charged with war crimes and crimes against humanity committed during the attacks against the civilian population in Darfur August 2003 – March 2004

Issued: 27 February 2007

4. Situation in the <u>Central African Republic</u> (CAR) – Referred: January 2005 Investigation opened: May 2007 Trial

The Prosecutor v <u>Jean-Pierre Bemba Gombo</u> – charged with war crimes and crimes against humanity, including a massive rape campaign, committed in CAR between 26 October 2002 – 15 March 2003

Status: Prosecution case presentation ongoing

5. Situation in <u>Kenya</u> – OTP request to start investigation: November 2009 Investigation opened: March 2010 Trials

The Prosecutor v William Samoei Ruto and Joshua Arap Sang – charged with crimes against humanity committed during the post-electoral violence in Kenya on or about 30 December 2007 – end January 2008

Status: Case sent to trial on 23 January 2012, date of trial to be set

The Prosecutor v Francis Kirimi Muthaura and Uhuru Muigai Kenyatta – charged with crimes against humanity committed during the post-electoral violence in Kenya 24 – 28 January 2008

Status: Case sent to trial on 23 January 2012, date of trial to be set

6. Situation in <u>Libya</u> – Referred: February 2011 Investigation opened: March 2011 Warrants Pending

The Prosecutor v <u>Saif Al-Islam Gaddafi</u> and <u>Abdullah Al Senussi</u> – charged with crimes against humanity committed during attacks on the civilian population by the Libyan Security Forces 15 February – at least 28 February 2011

Issued: 27 June 2011; Pre-Trial Chamber I ordered the termination of the case *the Prosecutor v. Muammar Gaddafi,* after Prosecution request (22 November 2011)

7. Situation in <u>Côte d'Ivoire</u> – OTP request to start investigation: June 2011 Investigation opened: October 2011 Warrant executed

The <u>Prosecutor v Laurent Gbagbo</u> – charged with war crimes and crimes against humanity committed after the November 2010 Ivorian elections.

Issued: 23 November 2011 (under seal)

27 January - HRW <u>wrote</u> to UN Secretary-General Ban Ki-Moon asking him to take action regarding the presence of UNAMID head Ibrahim Gambari at the wedding of President Deby to the daughter of Musa Hilal, attended by President Al-Bashir. In the letter, it was recalled that UN guidelines limits interactions with individuals indicted by international tribunals to "what is strictly required for carrying out UN mandated activities" and that "interactions of a ceremonial nature with President Al-Bashir should be avoided, including courtesy calls, receptions, photo opportunities, attendance at national day celebrations and so on". On 1st February, the UN spokesperson <u>indicated</u> "Mr. Gambari's attention has been drawn to the letter and to the

need to avoid such encounters in future, however unintentional this particular encounter may have been".


31 January - The leaders of the AU at the summit in Addis Ababa <u>asked</u> the Chairperson to consider seeking an advisory opinion of the International Court of Justice regarding the immunity of state officials under international law, although the AU Commission has not yet made any move in this direction. In 2000 the ICJ held in its ruling on the *Congo vs. Belgium* that there are certain exceptions to the principle of immunity of serving officials where an incumbent "may be subject to criminal proceedings before certain international criminal courts, where they have jurisdiction. Examples include the ICTY, the ICTR....and the future ICC".

IV. Other Co-operation

A recent study (Tweetminster and Portland) of African use of Twitter, based on an analysis of over 11.5million (geo-located only) Tweets from the last quarter of 2011, shows that Kenyans are the second most active users of this social networking tool on the African continent, with almost 2.5 million Tweets. The chart below shows how the usage of the hash tag #ICC peaks at the moment of the confirmation of charges decision. This is just one view of activity. Twitter users use a variety keywords to comment and share information on events related to the ICC proceedings in Kenya (icc, ruto, kenyatta, ocampo, ekaterina, justice, PEV, suspects, etc.). It reflects the continued high public interest in ICC proceedings.

VI. Other Information

- 31 January Professor Héctor Olásolo gave an OTP Guest Lecture at the Court presenting his latest book, "Essays on International Criminal Justice". His presentation examined the preventative mandate of the ICC, the complementarity regime, the new role granted to victims, and the prosecution of the highest leadership through the notion of indirect perpetration.
- 2 February The Dutch Preliminaries of the ICC Trial Competition will take place at Utrecht University. The hearing will be followed by a seminar on the "Core role of international justice and human rights research for the work of the ICC and other international judicial institutions based in the Netherlands".

In accordance with Article 42 of the Statute, the ASP shall elect one Deputy Prosecutor out of a list of three submitted by the Prosecutor in its November session. In order to ensure that States Parties have sufficient time to make a choice between the three candidates, the Office published a vacancy announcement on 26 January 2012. Having informally been told by the Vice-President of the ASP, Ambassador Markus Börlin, that some States desired more time to process the vacancy announcement, the Office decided to extend the period for an additional month, until 31 March 2012. The Office intends to submit the three names to the ASP in July 2012.
