Analyse, design, and implement user requirements in a .NET application and ensure a highly reliable, secure and scalable infrastructure compliant to best practices and well prepared for future demands.

#### **DESCRIPTION AND SCOPE OF WORK**

It is envisaged that the selected vendor will assist the ICC in enhancing the aforementioned application and that the costs associated with such service will be charged as a fixed price project in response to ICC explicit demands in the form of the described deliverables.

The selected vendor will work together with the team at the ICC premises in order to 1) analyse, design, and implement user requirements in a custom application partially develop using the Microsoft .NET Framework, 2) perform a health check on the application hosting infrastructure settings with regards to performance, security, etc. in order to validate it complies with best practices and ensure its operation at maximum security and efficiency levels. The consultant will also evaluate security compliance with the Court Information Security Standards and Guidelines
