CONTRIBUTIONS

Approved budget for 2010	103,623,300 euros	100%

Outstanding contributions for 2009 and 2008 stand at 0.36% and 0.12% respectively.		

HUMAN RESOURCES

As of 30 September 2010, the Court included 697 staff on established posts (353 professional staff and 344 General Service staff), 202 persons on General Temporary Assistance (GTA), 52 consultants or contractors and 97 interns or visiting professionals.

On 30 September 2010, staff subject to geographical representation were distributed as follows (in comparison with target figures):

- 15,46% from the Group of African States (target: 12.57%)
- 6,94% from the Group of Asian States (target: 18.54%)
- 6.94% from the Group of Eastern European States (target: 8.28%)
- 8.52% from the Group of Latin American and Caribbean States (target: 14.24%)
- 62.15% from the Group of Western European and other States (target: 46.38%)

72 nationalities are represented amongst the professional staff on established posts.

Gender balance amongst professional staff on established posts: 49.58% female (42.42 % of the applications to the Court are sent by women) and 50.42% male (57.58% of the applications are sent by male).

Since the beginning of the year, the Court has received 8,662 applications (by comparison, the total number received for 2009 was 13,902).

HEARINGS, DECISIONS AND FILINGS

Hearings

From 1 January to 30 September 2010, the Court held 192 hearings for a total of 556 hours.

The proceedings are held in open sessions unless ordered otherwise. It is possible to follow the hearings on the ICC website with a 30 minute delay in transmission.

Decisions and documents

Since the beginning of the year, 744 decisions, orders or judgments (representing 6,506 pages) including annexes were delivered, while 4,497 documents (representing 64,771 pages), including annexes, were registered.

VICTIMS AND WITNESSES

Witness protection

The Registry organized and implemented all the necessary logistical arrangements for the unhindered and timely appearance of victims and witnesses at the seat of the Court. The services included organizing the safe movement of victims and witnesses; providing travel documents and assistance with immigration procedures; providing psycho-social and practical assistance in the field.

Victim participation and reparation

Since investigations began, 4,101 victims have applied to participate in proceedings pertaining to situations (1,057 in the situation in the Democratic Republic of the Congo, 933 in the situation in Uganda, 197 in the situation in Darfur, 1,855 in the situation in the Central African Republic and 59 in the situation in Kenya), including 2069 from 1 January to 30 September 2010 (36 in the situation in the Democratic Republic of the Congo, 232 in the situation in Uganda, 56 in the situation in Darfur, 1,688 in the situation in the Central African Republic and 57 in the situation in Kenya).

Of the 4,101 victims, 905 were authorised by the relevant Chamber to participate in the proceedings.

Number of victims accepted to participate in the situations: 196 in the situation in the Democratic Republic of the Congo, 21 in the situation in Uganda, 11 in the situation in Darfur, Sudan and 108 in situation in the Central African Republic.

Number of victims accepted to participate in the cases: 103 in the *Lubanga* case, 362 in the *Katanga and Ngudjolo Chui* case, 41 in the *Kony et al.* case, 135 in the *Bemba* case, 87 in the *Abu Garda* case, 6 in the *Harun* case and 12 in the *Al Bashir* case.

Since 1st of January 2010, the Court received 615 applications for reparations from victims, bringing the total to 743 applications.

DEFENCE AND COUNSEL

Four accused are detained at the ICC Detention Centre (Thomas Dyilo Lubanga, Germain Katanga, Mathieu Ngudjolo Chui and Jean-Pierre Bemba Gombo).

Indigence: Jean-Pierre Bemba Gombo has been declared not indigent while 6 other suspects were declared indigent (Thomas Dyilo Lubanga, Germain Katanga, Mathieu Ngudjolo Chui, Abu Garda, Abdallah Banda and Saleh Mohammed Jerbo).

Lists of counsel, assistants to counsel and professional investigators

Since the beginning of 2010, the Court has received 57 applications to be included in the list of counsel; 16 applicants were added to the list, bringing the total to 342 (63 women and 279 men) from 49 countries. The number of assistants to counsel has increased from 59 to 67 since 1 January 2010 and the list of professional investigators includes 27 investigators

The eight edition of the Seminar of Counsel, which is organized annually by the Registry in accordance with the *Regulations of the Registry* took place on 17 and 18 May 2010. A three-day training workshop followed the seminar.

OUTREACH and PUBLIC INFORMATION

Since 31 March 2010, the official ICC YouTube channel allows viewers to follow in particular the various cases before the ICC, thanks to weekly, uploaded summaries of the proceedings under the title In the Courtroom. The playlist *In the Field* includes Court outreach activities conducted in situation-related countries. Also available are the programmes, “Ask the Court” with responses to frequently asked questions, and at *Meeting the Press*, conferences and briefings with journalists. Videos are produced in English, French and Arabic. Since 1st January 2010, 55 audio and video summaries have been produced for international media and 78 radio programmes and 57 video programmes have been produced for outreach purposes.

From 1st January to 30 September 2010, 103 press releases and advisory materials have been distributed while 864 interviews have been given by the officials of the Court. At the Headquarters of the Court, 397 visits have been organized for a total of 6,461 persons.

Since 1 January 2010, outreach activities (meetings, workshops and seminars) were carried out as follows in the situation countries:

- Northern Uganda: during 106 interactive sessions, 20,838 people have been engaged directly, and an average of ten million people per month have been reached through radio broadcasts.
- Democratic Republic of the Congo: during 172 activities, 16,419 people were directly engaged and an estimated audience of 25 million were regularly informed each month, through radio and television broadcasts.
- Central African Republic: during 67 interactive sessions held between January and September 3,366 people were directly engaged and 800,000 people were regularly informed via the radio and television.
- Darfur: the activities have continued with the Sudanese diaspora, informing refugees in Eastern Chad and the media. 52 meetings have directly engaged 1,630 people. Through radio broadcasts and the posting of information on the Sudanese Online website, an estimated audience of 10 million have been regularly informed.

FIELD OPERATIONS

To date, five field offices have been established in or near the situations under investigation (Kinshasa and Bunia in the Democratic Republic of Congo, Kampala in Uganda, Bangui in Central African Republic and Abeche in Chad in relation to the situation in Darfur). The Field Operations Section works to the closure of the office in Abéché mid 2011 and to the establishment of a field presence in Kenya.

From 1st January to 30 September 2010, 555 missions (286 external missions externes et 269 internal missions) were supported by the Field Operations Section as follows : 135 missions in Uganda, 295 in DRC, 35 in Chad 31 in Kenya and 59 in Central African Republic).
