The Secretariat of the Assembly of States Parties presents its compliments to States and, in light of the resumed thirteenth session of the Assembly, to be held from 24 to 25 June 2015, at the Ministry of Foreign Affairs of the Netherlands, located at Bezuidenhoutseweg 67, 2594 AC The Hague, wishes to inform States that, in order to obtain access passes to the Ministry of Foreign Affairs, delegates are required to submit a registration form.

The Secretariat of the Assembly kindly requests that the enclosed registration form be submitted to the Secretariat (by fax to: +31-70-515-8376 or by e-mail to asp@icc-cpi.int) at their earliest convenience but **no later than 22 June**, so as to expedite the issuance of conference badges for the resumed thirteenth session, as well as the compilation of the List of Participants of the resumed thirteenth session.

The on-site registration of participants will start at the Ministry of Foreign Affairs on Wednesday, 24 June from 08:30 hours. Conference passes will be issued upon presentation of valid identification, preferably a passport.

The Hague based delegates of States Parties who are in possession of an ICC badge can access the Ministry of Foreign Affairs upon presentation of their ICC badge and valid identification. Delegates who are in possession of an ICC badge are still required to submit the registration form for the compilation of the List of Participants.
