The Group of Independent Experts is pleased to present its final Report on the review of the International Criminal Court and the Rome Statute system, as requested by the Assembly of States Parties to the Rome Statute of the International Criminal Court in December 2019 through its resolution ICC-ASP/18/Res.7. The Report is submitted pursuant to the Assembly's request that the Experts present their final report and recommendations to the Bureau, the Assembly, the Court and other stakeholders no later than 30 September 2020.

The full Report is issued together with the French translation of its Introduction and Annex I, containing a summary of the recommendations that the Experts advise should receive priority. The Experts would have preferred to issue the full Report in both English and French simultaneously. However, to ensure full confidentiality of the Report, its content has not been shared with any third party prior to this public issuance. The Secretariat of the Assembly has made arrangements for the translation of the full Report to begin today.
