The Secretariat of the Assembly of States Parties presents its compliments to States Parties and, on behalf of the President of the Assembly, has the honour to refer to its notes verbales ICC-ASP/25/SP/55, ICC-ASP/25/SP/106 and ICC-ASP/25/SP/108 of 17 March, 20 July and 4 August 2026, and to resolution ICC-ASP/1/Res.5 on the procedure for the nomination and election of members of the Committee on Budget and Finance. Under the terms of paragraph 4 of the aforementioned resolution, the Secretariat wishes to inform States Parties that, as at 16 August 2026, the status of nominations for the election was as follows:

As indicated in Table A above, the number of candidates remains less than the number of seats available for the Group of Latin American and Caribbean States.

As indicated in Table B above, the number of candidates remains less than the number of seats available for the election to fill one seat pursuant to resolution ICC-ASP/22/Res.8 for the Group of Eastern European States.

In accordance with paragraph 4 of resolution ICC-ASP/1/Res.5, the nomination period for the election of members of the Committee on Budget and Finance has been extended for the third and final time, for a period of two weeks, until **Sunday, 30 August 2026 (Central European Time)**.

States Parties are requested to transmit nominations through the diplomatic channel to the Secretariat of the Assembly of States Parties, Oude Waalsdorperweg 10, 2597 AK The Hague, The Netherlands, or via e-mail to asp@icc-cpi.int, to be received by the Secretariat of the Assembly before midnight (Central European Time) on Sunday, 30 August 2026. If feasible, the Secretariat would appreciate receiving the Word versions of the nominations, as well as of the accompanying statements and other supporting documentation.
