**Report of the Advisory Committee on Nominations of Judges  
on the work of its ninth session**

**Addendum**

1. This addendum is submitted further to the report of the Advisory Committee on Nominations of Judges on the work of its ninth session (ICC-ASP/22/4); annex III, recommendation 3; and annex IV of the report.

2. Paragraph 21 of the report states:

“21. Regarding the preparation of guidelines for the national-level nomination procedures, the Committee was of the view that additional submissions were required in order for it to effectively carry out this mandate. The Committee called upon all States Parties to submit to the Secretariat “information and commentary on their own existing or prospective national nomination and selection procedures”<sup>1</sup> as soon as possible, in order to facilitate its work on the preparation of the guidelines. The Committee noted that an in-person meeting of three days’ duration would be necessary in 2024 in order for the Committee to fulfil the mandate to complete the guidelines. The proposed budget for this meeting in 2024 is set out in annex IV.”

3. Annex III, recommendation 3, of the report states as follows:

**3. Recommendation concerning an in-person meeting of the Committee in 2024**

“The Committee recommends that the Assembly consider approving the appropriate resources for the Committee to meet in person in 2024, in order to fulfil the mandate to prepare guidelines for national-level nomination procedures (see annex IV).”

4. Annex IV of the Committee’s report sets out the proposed budget for a three-day meeting of the Committee in The Hague.

5. The Committee has subsequently decided to recommend that the Assembly approve the resources for a second three-day meeting in The Hague, in order to enable it to better complete its mandate set out in resolution ICC-ASP/21/Res.2, annex III. The meetings would consist of (1) a first meeting to review the submissions received from States Parties on their national nomination procedures and the preparation of draft Guidelines to States Parties on the basis of the responses received, which the Committee will circulate to States Parties for comments; and (2) a second meeting which will enable the Committee to finalize the Guidelines, on the basis of the comments received from States Parties.

6. The present addendum to the report of the Advisory Committee relates to the holding of two three-day meetings of the Committee in 2024. This addendum contains a new annex to the report of the Committee, annex V, which reflects the budget estimates for the two three-day meetings that the Committee envisages in 2024. The budget is comprised of travel costs only. Interpretation costs have not been included since it would be possible for the Committee to work in English only, on this occasion.
