# **Election of members of the Committee on Budget and Finance**

#### Note by the Secretariat

- 1. On 6 March 2024, the Bureau of the Assembly of States Parties decided that the nomination period for candidates for the election of five members of the Committee on Budget and Finance to be held at the twenty-third session of the Assembly pursuant to resolution ICC-ASP/22/Res.8 would run from 3 June to 25 August 2024 (Central European Time).
- 2. The Committee on Budget and Finance was established by the Assembly in its resolution ICC-ASP/1/Res.4 of 3 September 2002. The terms of reference of the Committee are set out in the annex to the resolution. Paragraph 2 of the annex to that resolution was amended by the Assembly by resolution ICC-ASP/2/Res.5 of 12 September 2003.
- 3. The procedure for the nomination and election of the members of the Committee was set out by the Assembly in its resolution ICC-ASP/1/Res.5. Paragraph 15 of that resolution was amended by resolution ICC-ASP/2/Res.4 of 12 September 2003. In accordance with paragraph 6 of resolution ICC-ASP/1/Res.5, each nomination shall specify how the candidate fulfils the requirements laid down in paragraph 2 of resolution ICC-ASP/1/Res.4, i.e. to be an expert of recognized standing and experience in financial matters at the international level from a State Party.
- 4. The distribution of seats among the regional groups pursuant to paragraph 8 of resolution ICC-ASP/8/Res.8 is as follows:
- African States, four seats;
- Asia-Pacific States, three seats;
- Eastern European States, three seats;
- Group of Latin American and Caribbean States, three seats; and

Western European and Other States, four seats.

- 5. The five new members would belong to the following regional groups:
  - (a) African States, two seats;
  - (b) Asia-Pacific States, one seat;
  - (c) Eastern European States, one seat;
  - (d) Latin American and Caribbean States, one seat.
- 5. As required by paragraph 9 of resolution ICC-ASP/1/Res.5, every effort shall be made to elect the members of the Committee by consensus, on the basis of a recommendation by

the Bureau. Under paragraph 10, in the absence of a consensus, the election shall be a matter of substance, and subject to the requirements of article 112, paragraph 7 (a), of the Rome Statute, which provides as follows:

- "7. Each State Party shall have one vote. Every effort shall be made to reach decisions by consensus in the Assembly and in the Bureau. If consensus cannot be reached, except as otherwise provided in the Statute:
- (a) Decisions on matters of substance must be approved by a two-thirds majority of those present and voting provided that an absolute majority of States Parties constitutes the quorum for voting."
- 6. In accordance with paragraph 11 of resolution ICC-ASP/1/Res.5, the election shall be by secret ballot. However, this requirement may be dispensed with if the number of candidates corresponds to the number of seats to be filled or in respect of candidates endorsed by the respective regional groups, unless a delegation specifically requests a vote on a given election.
- 7. Under paragraph 12 of the resolution, the persons elected shall be those candidates from each regional group who obtained the highest number of votes and a two-thirds majority of States Parties present and voting, provided that an absolute majority of the States Parties constitutes the quorum for voting.
- 8. On the closing date of the nomination period, 25 August 2023, the number of candidates was less than the number of seats and not all regional groups had submitted a candidate. The President, pursuant to resolution ICC-ASP/1/Res.5, extended the nomination period for two weeks, until 8 September 2024. Since the number of candidates remained less than the number of seats and not all regional groups had submitted a candidate, the President extended the nomination period for a period of two weeks on two respective occasions, until 22 September and 6 October 2024 (Central European Time).
- 9. At the end of the extended nomination periods, four candidatures had been received.
- 10. Of the four nominations, two were submitted by the group of African States, one by the group of Eastern European States and one by the Group of Latin American and Caribbean States.
- 11. In accordance with paragraph 7 of resolution ICC-ASP/1/Res.5, a list in the English alphabetical order of all persons nominated, with accompanying documents, is contained in the annex to the present note.

#### Statement of qualifications

Statement submitted in accordance with paragraph 6 of the resolution ICC-ASP/1/Res.5, as amended by ICC-ASP/2/Res.4, adopted by the Assembly of States Parties, relating to the procedure for the nomination and election of the members of the Committee on Budget and Finance of the International Criminal Court (CBF)

#### Professional background and experience

Mr. Kim Jae Woo, who has served as a diplomat for the Republic of Korea at various posts since 1997, meets the requirements set out in the terms of reference of the CBF. Throughout his career, Mr. Kim has acted with the integrity and high standing required of a diplomat. He has extensive experience in the administration of international organizations, including budgetary and financial matters, and has wide-ranging diplomatic expertise. He is currently serving as the International Affairs Coordinator at the Supreme Court of Korea on a temporary assignment and is scheduled to return to the Ministry of Foreign Affairs in January 2025.

#### **Experience in International Organizations**

Mr. Kim has extensive experience in matters related to international organizations. His responsibilities have covered not only political affairs, but also governance issues, within these organizations. As a Director and Policy Officer within the Ministry of Foreign Affairs, he has actively engaged in budgetary and financial discussions and played a supervisory role in various international organizations, including:

#### Legal Affairs: ICC, ICJ, PCA, ICTY, HCCH

- O **Disarmament**: Organisation for the Prohibition of Chemical Weapons (OPCW), Preparatory Commission for Comprehensive Nuclear Test Ban Treaty Organizations
