Statement of Qualifications

1. Professional Background and Experience

Ms. Sawada Satoko has served as a diplomat at the Ministry of Foreign Affairs of Japan, meeting the requirements set out in the terms of reference of the CBF. She has extensive experience in the financial and budgetary affairs of international organizations, as well as in international law and dispute settlement. She is currently serving as First Secretary at the Permanent Mission of Japan to the International Organizations in Geneva.

2. Experience in Multilateral For a

Ms. Sawada has broad experience of engaging with international organizations across a wide range of fields. In her current post in Geneva, she oversees budgetary, governance and management matters of various organizations, including IOM, OCHA and UNDRR, and actively participates in intergovernmental discussions on behalf of Japan. In the context of the UN80 Initiative, she has been engaged in discussions on financial sustainability and the efficient allocation of resources, working closely with member states on budgetary and organizational reform. Prior to her current posting, she was responsible for legal affairs relating to international judicial bodies, including the ICC, ICJ and PCA.

Having served in the International Judicial Proceedings Division of the Ministry of Foreign Affairs, she has acquired in-depth knowledge of the Rome Statute and the ICC rules and regulations, which will be a significant asset in fulfilling her duties on the CBF.

In Geneva, she has analyzed budgets and financial reports of multiple international organizations and engaged in related intergovernmental discussions. These experiences have equipped her with the analytical rigor and drafting precision required for the preparation of CBF reports and recommendations to the Assembly of States Parties.
