## HIS EXCELLENCY STEPHEN FLETCHER SPEECH DELIVERED AT THE INTERNATIONAL CRIMINAL COURT ON 23<sup>RD</sup> AUGUST 2011 FOR THE OCCASION OF THE OFFICIAL WELCOMING CEREMONY FOR GRENADA'S ACCESSION TO THE ROME STATUS OF THE ICC

Let me begin by expressing warm Caribbean and indeed Grenadian greetings on behalf of the Government and Peoples of Grenada, and specifically on behalf of the Prime Minister, His Excellency Tillman Thomas, who is also Minister for Legal Affairs.

I am also proud to be delivering this message today in an institution which was founded on the dreams of a Leading Caribbean Politician and Jurist- former Prime Minister of Trinidad and Tobago A.N.R. Robinson who approximately 23<sup>rd</sup> years ago called for the establishment of this

court.

Mr. President, Judges, Excellences, Ladies and Gentleman,

Today more than two-thirds of the world's Nation States have ratified the Rome Statute.

Grenada is pleased to be part of this growing number of states

By so doing, Grenada is helping to add weight to this court and consolidate its' in the

international Criminal justice system.

Grenada is pleased to be associated with the International Criminal Court since we believe that the International Criminal Court represents a source of global transparency and global

accountability within the Global Legal and Human Rights Framework.

Today, Grenada is breaking with the adagewhich says, "it is only necessary for good men to do

nothing for evil to triumph"; today Grenada is acting to prevent the triumph of evil.

Today Grenada's action is sending a clear statement to the world, that it does not intend to

allow crimes against humanity to escape the global justice system.

Mr. President, Judges, excellences, Ladies and Gentleman,

Grenada's commitment to the Rome Statute and the International Criminal Court is a clear and

unequivocal indication of our confidence in our own domestic legal system.

Grenada, despite our size, wishes to be at the table where we can help shape the Global Legal System.Grenadaseeks to prevent International Crimes and help secure a peaceful, stable and

secure world.

Moreover, this ceremony today, highlights my country's commitment to the respect for Rule of

Law and Human Rights. While courts are generally set up to act after a deviation from the law

has occurred, we hope that the Legal Infrastructure could also be proactive, developmental and

act in ways that would remove the basis on which such deviations occur.

Mr. President, Excellencies,

It is within this context we need to act collectively, to promote an appropriate development Agenda which seeks to inter alia, among other things to:

✓ Improve Legal and Social Conditions of State parties

✓ Enhance and help countries improve their legal infrastructure

✓ Assist countries, especially post conflicts countries to enshrine and exercise respect for fundamental principles of Human Rights and Human Dignity with in their constitution

and legal system.

Mr. President, Judges, Excellences, Ladies and Gentleman,

Let me end by reiterating my country's commitment to the International Criminal Court and to the Rome Statute, despite the real resource constraints facing my country. It is a difficult choice

but one which we cannot ignore.

As a small developing country, we truly believe in peace trough stability.

In this context it is important that we became part of this most august body, we recognize that the court by itself cannot put an end to impunity. It requires the unwavering support of State parties, international organisation, Non-Governmental organisations and individuals who share

our common purpose.

Mr. President, Judges, Excellences, ladies and Gentlemen

Today's ceremony confirms and clearly demonstrates Grenada's commitment to the rule of law and good governance, and moreover, our willingness to do whatever we can to help promote

peace among men.
