# Dr. Philipp Ambach,

Dr. Philipp Ambach is the Chief of the Victims Participation and Reparations Section in the Registry of the International Criminal Court (ICC). Prior to that, he worked for more than six years in the Presidency of the ICC as the President's Special Assistant, and as a project-based legal office (one of two project team leaders) in the ICC Registry (2015). Before that, Mr. Ambach worked for four years as an associate legal officer in the Appeals Chamber of the ICTY, ICTR, as well as in the Registry of the ICTY. After finishing his Master's degree in law at the Humboldt-University of Berlin (Germany) and subsequent employment at the Regional Court of Düsseldorf, Mr. Ambach was accepted at the Cologne Public



Prosecutor's Office as prosecutor. He holds a Ph.D. in international criminal law of Free University of Berlin.

His publications touched, inter alia, on relevant provisions of the Rome Statute, including the war crimes provision (article 8), as well as the ICC institutional framework and management structure; performance indicators for international criminal courts; victim participation and reparations at the ICC and hybrid tribunals; streamlining of the criminal process before the ICC; topics of self-representation in international criminal trials (with a focus on ICTY/ICTR); the relationship between internationalised hybrid criminal tribunals and the ICC; international criminal liability of economic actors for their involvement in armed conflict.

#### Mr. Gilbert Bitti

Gilbert Bitti is Senior Legal Adviser to the Pre-Trial Division of the International Criminal Court (ICC). He has been a member of the French Delegation during the ICC negotiations in the Ad Hoc Committee (1995), Preparatory Committee (1996-1998), Rome Conference (1998) and Preparatory Commission (1999-2002). Before that, he was Counsel to the French Government at the European Court of Human Rights (1993-2002). He is also a former Assistant Professor at the Faculty of Law in Paris. Bitti is the author of numerous publications on the ICC and he speaks regularly at academic conferences on international criminal justice.



## Ms. Eleni Chaitidou

Eleni Chaitidou studied law in Germany where she passed both State Examinations in Law. She worked for several years at the Law Faculty of the University of Munich in the field of Public International and European Community Law. In 2006 she joined the International Criminal Court (ICC) where she works as a Legal Officer in the Pre-Trial and Trial Divisions. Ms. Chaitidou regularly lectures and publishes on selected issues of international law and the ICC's case law. She is a member of the editorial board of the Criminal Law Forum and editor with Torkel Opsahl Academic EPublisher.



#### Ms. Julie de Hults

Julie de Hults is a Legal Advisor at the Belgian Ministry of Justice where she holds the position of Deputy Head of the Belgian Central Authority for Cooperation with the International Criminal Court and other international criminal jurisdictions. She has been part of the Belgian Delegation at the Assembly of States Parties to the Rome Statute of the International Criminal Court since 2008. Her work focuses on cooperation issues with international criminal jurisdictions as well as interstate cooperation in matters relating to war crimes, crimes against humanity and crimes of genocide. She holds a Bachelor in Law from the Facultés universitaires Saint-Louis (Brussels) and a LL.M. in Criminology from the Université Catholique de Louvain.



#### **Dr. David Donat Cattin**

David Donat Cattin (Ph.D Law, Italy) is the Secretary General of Parliamentarians for Global Action (PGA). Over the last 17 years, Dr. Donat Cattin worked with PGA's International Law & Human Rights Programme to promote the universality and effectiveness of the International Criminal Court (ICC) Statute in more than 100 countries. With his assistance, PGA Members contributed to the ratification process of 77 out the current 124 States Parties to the Rome Statute, including the ratifications/accessions by Japan (2007), The Philippines, The Maldives, Cape Verde and Vanuatu (2011), as well as Côte d'Ivoire (2013) and El Salvador (2016). Dr. Donat Cattin holds a Ph.D in Public International Law (2000)



from the University of Teramo (Italy), Faculty of Law, and a 'magna cum laude' law degree (1994) from the LUISS-Guido Carli University (Rome, Italy), as well as a post-Ph.D. diploma from the Center for Studies and Research of the Hague Academy of International Law (2002). His writings on international criminal law appeared on well-known scholarly works, such as Triffterer's "Commentary on the Rome Statute of the ICC" (I ed. 1999; II ed. 2008; III ed. 2016) and Lattanzi/Schabas "Essays on the Rome Statute of the ICC" (vol. I, 1999; vol. II, 2004). He recently co-edited "International Law & the Protection of Humanity" (2017). Since May 2012, he is an "Adjunct Assistant Professor" of International Law at New York University (NYU), Center for Global Affairs. Since August 1999, he is a lecturer at the Salzburg Law School on International Criminal Law, Humanitarian Law and Human Rights Law, Faculty of Law, University of Salzburg (Austria).

Dr. Donat Cattin is a frequent lecturer in international criminal justice subjects and he was heard as expert-witness on the ICC and its impact on conflicts in Africa by the German Bundestag, Committee on Human Rights and Humanitarian Affairs (Sept. 2007) and on the situation in Darfur by the Italian Chamber of Deputies, Sub-Committee on Human Rights (Dec. 2008 and Feb. 2009). He also intervened on the ICC and the fight against impunity and on the Kampala Amendments in the European Parliament, Sub-Committee on Human Rights (April 2010 and February 2015 respectively) and Foreign Affairs Committee (April 2017), in the plenary of the Africa-Caribbean-Pacific—European Union Joint Parliamentary Assembly (March 2008) and in the Legal Affairs and Human Rights Committee of the Parliamentary Assembly of the Council of Europe (May 2016).

#### Ms. Franziska Eckelmans

Franziska Eckelmans has a German legal background (1st and 2nd State Exam in Law) and worked at the International Criminal Court (ICC) from 2003 until 2016, among others as Associate Legal Officer, Legal Officer at the Appeals Chamber of the International Criminal Court as well as Legal Advisor of the same Chamber (2016). At the early stages of the ICC, in 2003/2004, she was a member of the Drafting Board of the Regulations of the Court. For many years, she was a member of the



ICC internal Legal Tools Advisory Committee and involved in setting up the Legal Tools website.

From 2009 to 2011, Franziska Eckelmans worked through CIM/GIZ (Centre for International Migration) as Legal Advisor at the Trial Chamber of the Extraordinary Chambers in the Courts of Cambodia (ECCC) during the hearing and judgment drafting stages of Case 001 (Kaing Guek Eav) and until the opening of the trial of Case 002 (Nuon Chea et al). In 2015, she was part of the Planning Team for the Kosovo Specialist Chambers situated in Brussels. Since mid-2016, she works as Legal Counsel for the Kosovo Specialist Chambers.

Franziska Eckelmans has published in the field of international criminal law, the most recent being "Der Anwalt in der Internationalen Strafgerichtsbarkeit" in "Internationales Strafrecht in der Praxis", 2017 (Ahlbrecht/Boehm/Esser/Eckelmans, eds), "The Duch Case: The ECCC Supreme Court Chamber's Review of Case 001" in "The Extraordinary Chambers in the Courts of Cambodia", 2016 (Meisenberg/Stegmiller, eds), Commentaries of Articles 81 and 83 (appeals) in the 2016 edition (3rd ed.) of the Triffterer/Ambos commentary. She has given numerous speeches on various topics relevant to international criminal law. Since 2005, she is a member of the coordination committee of the German speaking working group on international criminal law (AK Internationales Strafrecht).

#### **Prof. Benjamin Ferencz**

Ben Ferencz, born in Transylvania in 1920, attended public schools in New York. He won a scholarship to Harvard Law School where he worked as a researcher for a professor writing a book on war crimes. He received his degree in 1943 and promptly joined the US army as a private in the artillery. He was awarded five battle stars for not being killed or wounded at Normandy Beach and every major campaign in Europe. As the war was ending, he was transferred to General Patton's HQ to serve as a



war crimes investigator. He entered many Nazi concentration camps as they were liberated. The horrors made an indelible impression. He returned home and was promptly recruited by General Telford Taylor to return to Germany to help in the additional war crimes trials. He was appointed Chief Prosecutor in what was aptly described as the biggest murder trial in history - the "Einsatzgruppen case". All 22 defendants, including six SS Generals, were convicted of murdering over a million innocent men, women and children. 13 defendants were sentenced to death. Ferencz was then 27 years old and it was his first case.

Almost all of his life since then has been spent trying to obtain compensation for victims and trying to prevent illegal war-making. He became a self-appointed personal lobbyist for peace, with countless lectures, publications and speeches in many universities and countries. For several years, he was an Adjunct Professor at Pace Law School where he taught "The International Law of Peace". He lives in New Rochelle, New York, and has been married to his wife, Gertrude, for over 70 years. They have four grown children. http://www.benferencz.org

#### **Prof. Gerhard Hafner**

Gerhard Hafner was born 3 August 1943, received his Dr. iur. 1966 at the Vienna university, further studies at Paris, The Hague, Moscow (1967 – 1968). He became Professor of international law and international economic law at the Vienna Law Faculty in 1990 and has been Visiting Professor in various other universities such as Stanford, Comenius University and Paneurópska vysoká škola in Bratislava or Paris II (IHEI), the Diplomatic Academy Vienna, and the University of Krems. He was Member of the International Law Commission 1997 – 2001.

He is Member of the Permanent Court of Arbitration and worked as arbitrator and counsel in various international cases, Membre de

l'Institut du Droit International, Conciliator at the OSCE Court and was 2006 – 2015 Member of the Governing Board of the European Studies Institute (Moscow).

His practical experience results from his activity in the Austrian Ministry for Foreign Affairs, lastly in 1993 – 1995 as Head of the Division of General International Law. where he is still legal consultant, as well as from his function as member and head of the Austrian delegations to various international conferences, including the Rome Conference for the ICC, where he had to act as chair of the European Union. Due to his participation in the entire preparatory process of the Rome conference and his activity at the Rome Conference he became fully involved in the topic of international criminal law. His bibliographical list encompasses books and articles on the most different fields of international law, including international criminal law as well as the law of the sea.

#### Ms. Michelle Jarvis

Ms. Jarvis has worked in the international criminal justice field for over 17 years and is presently the Deputy Head of the International, Impartial and Independent Mechanism on Syria (IIIM), having taken up the post in December 2017. Prior to that she was the Deputy to the Prosecutor at the International Criminal Tribunal for the former Yugoslavia (ICTY) and the Mechanism for International Criminal Tribunals (MICT). She has also worked in legal practice in Australia, as well as with the United Nations Division for the Advancement of Women. Ms. Jarvis has extensive expertise on issues concerning gender and armed conflict. She has co-authored two books on this subject and she also initiated and currently serves on the Advisory Council of the Prosecuting Conflict-Related Sexual Violence Network established within International



Association of Prosecutors in 2015. Ms. Jarvis is also a Co-Vice Chair of the International Bar Association's War Crimes Committee. Ms. Jarvis holds a Master's degree in law from the University of Toronto as well as degrees in law and economics from the University of Adelaide.

#### Prof. Claus Kreß

Claus Kreß (Dr. jur. Cologne; LL.M. Cantab.) is Professor for Criminal Law and Public International Law. He holds the Chair for German and International Criminal Law and he is Director of the Institute of International Peace and Security Law at the University of Cologne. He declined a call to the Max-Planck-Institute for International, European and Regulatory Procedural Law in Luxembourg. His prior practice was in the German Federal Ministry of Justice on matters of criminal law and international law. Since 1998 he has been a member of Germany's delegations in the negotiations regarding the International Criminal Court. He served as a War Crimes Expert for the Prosecutor General for East Timor (2001), as Head of the ICC's Drafting Committee for the Regulations of the Court (2004), as a sub-coordinator in the



negotiations on the crime of aggression, and as a Special Advisor to the Independent Israeli Public Commission to Examine the Maritime Incident of 31 May 2010 ('Turkel Commission') - Second Report (2011-12). His more than 150 publications cover both Criminal and Public International Law with an emphasis on the International Law on the Use of Force, the Law of Armed Conflicts and International Criminal Law. Kreß serves on the editorial board of several law journals, including the Journal of International Criminal Justice and the Journal of the Use of Force and International Law. He was a Visitor at the Lauterpacht Centre for International Criminal Law (2010), at Columbia Law School (2015/2016) and at Melbourne Law School (2017). He currently holds a Fernand Braudel Senior Fellowship at the European University Institute in Florence. He is a Life Member of Clare Hall College at the University of Cambridge, a Member of the Academy of Sciences and Arts of Northrhine-Westfalia, and the recipient of the 2014 M.C. Bassiouni Justice Award. He was awarded Honorary Doctorates from the Universities of Huánuco and Tbilisi.

#### Prof. Susan R. Lamb

Susan Lamb has worked for almost 20 years with various United Nations and other responses to atrocity crimes. She is a former Senior Legal Officer to the Trial Chamber of the United Nations Assistance to the Khmer Rouge trials (UNAKRT) in Phnom Penh, Cambodia (2009-2013), Chef de Cabinet to the Presidency and Senior Legal Officer to Trial Chamber I of the United Nations International Criminal Tribunal for Rwanda (ICTR) in Arusha, Tanzania (2005-2008) and also worked in various capacities for the the United Nations International Criminal Tribunal for the former Yugoslavia (ICTY) Office of the Prosecutor and Chambers in The Hague (1997-2005). More recently, she has worked on related civil society initiatives seeking accountability for serious violations of international criminal and humanitarian law committed in the course of the Syrian conflict. She is currently a



Visiting Professor at the Universidade NOVA de Lisboa in Lisbon, Portugal, where she teaches and researches in the area of international criminal justice. She has served previously as Professor, Vice Dean and Executive Director of the Centre for International Criminal Justice and International Humanitarian Law at the Jindal Global Law School in India, as well as teaching or lecturing at a variety of other Universities in Europe, North America and Australasia. She received her Bachelor of Arts and Bachelor of Law degrees from the University of Otago in Dunedin, New Zealand and undertook doctoral studies at Balliol College, Oxford in the mid-1990s as a Rhodes Scholar. She is admitted as a barrister and solicitor of the High Court of New Zealand.

#### Prof. Suzannah Linton

Professor Suzannah Linton is Distinguished Professor at the Law School of Zhejiang Gongshang University in Hangzhou, China, a position held in conjunction with a Thousand Talent Award from the People's Republic of China. She has over 25 years of experience in the field of International Law as an academic and practitioner. Professor Linton was previously the Chair of International Law at Bangor University in the UK, and Associate Professor of Law at the University of Hong Kong. Her professional experience includes serving as a United Nations Prosecutor in East Timor, International Law advisor to the East Timor Truth Commission, Consultant to the United Nations in Cambodia, Moldova and elsewhere, and as Law Clerk to Judges Cassese and Mumba at the International Criminal Tribunal for the former Yugoslavia.



Professor Linton's research is widely published, and she lectures around the world as a visiting professor, guest lecturer and conference speaker. In 2017, she was elected to the International Institute of Humanitarian Law in San Remo, Italy.

Professor Linton is a co-editor of the Oxford University Press Monographs in International Humanitarian and Criminal Law, and she serves on the editorial boards of several law journals. She is, together with Professor Tim McCormack of Melbourne University and Professor Sandesh Sivakumaran of Nottingham University, presently co-leading a major project involving over 50 experts entitled Perspectives on International Humanitarian Law on and from the Asia-Pacific, to be published by Cambridge University Press in 2019.

# Ms. Angela Mudukuti

Angela Mudukuti (https://angelamudukuti.com) is a Zimbabwean international criminal justice lawyer currently with the Wayamo Foundation. Formerly with the Southern Africa Litigation Centre (SALC) in South Africa, Angela worked on precedent setting cases on crimes against humanity before the Constitutional Court and was involved in advocacy and strategic litigation, including taking the South African government to court for failure to arrest President Bashir of Sudan. Prior to joining SALC, Angela worked for the Immediate Office of the Prosecutor at the International Criminal Court in The Hague, and under the supervision of Prof Cherif Bassiouni at the Siracusa International Institute for Criminal Justice and Human Rights in Italy. Prior to that Angela was in private



practice in Zimbabwe working on civil and criminal matters. Angela has a masters degree in international criminal law and transitional justice and an undergraduate law degree.

# **HE Judge Kimberly Prost,**

Judge Kimberly Prost serves at the International Criminal Court as of 11 March 2018, for a term of nine years.

Prior to her election as judge of the ICC, Judge Prost served as Chef de Cabinet for the President of the International Criminal Court for a two year term. Before joining the Court, she was appointed in 2010 as the first Ombudsperson for the Security Council Al Qaida Sanctions Committee.

In July 2006, after election by the United Nations General Assembly, she was appointed to sit as an ad litem judge of the International Criminal Tribunal for the former Yugoslavia on a multi-accused trial (Popovic et al) related to events at Srebrenica and Zepa.



Earlier in her career, Judge Prost worked for the Canadian Department of Justice for 18 years appearing before all levels of the Canadian courts, including the Supreme Court. For 7 years she served as Director of the International Assistance Group which is responsible for extradition and mutual legal assistance matters for Canada. She participated in negotiating over 40 extradition/mutual legal assistance treaties and was a member of the Canadian delegation for negotiating the Rome Statute of the International Criminal Court and related documents, as well as the UN Conventions against Transnational Organized Crime and Corruption.

Judge Prost also held managerial positions with the Commonwealth Secretariat and the UN Office on Drugs and Crime delivering a range of programmes for States on international cooperation, money laundering and asset forfeiture, counter terrorism, implementation of the Rome Statute, and combating organized crime and corruption.

Judge Prost graduated as a gold medallist from the University of Manitoba Law School.

#### Dr. Astrid Reisinger Coracini

Astrid Reisinger Coracini is a postdoctoral lecturer and researcher at the Institute of European, International and Comparative Law at the University of Vienna and Director of the Salzburg Law School on International Criminal Law, Humanitarian Law and Human Rights Law (http://sls.sbg.ac.at). Previously, she was a Visiting Researcher at the New York University, Assistant Professor at the Institute of International Law and International Relations of the University of Graz, Austria, and Research Assistant for international and comparative criminal law at the University of Salzburg (Prof. Otto Triffterer). Her research focuses on theory and sources of international law, the use of force, and international criminal law.



Ms. Reisinger Coracini was also responsible for the development of an international and interdisciplinary master programme in anti-corruption studies at the International Anti-Corruption Academy and served as Legal Officer at the Austrian Federal Ministry for Foreign Affairs. She holds a master and a doctorate degree in law from the University of Graz.

Ms. Reisinger Coracini participated in the negotiations of the Special Working Group on the Crime of Aggression as an individual expert and has been a member of the Austrian delegation at sessions of the Assembly of States Parties and at the first Review Conference of the Rome Statute of the International Criminal Court in Kampala. On national level, she was a member of the expert groups for the implementation of crimes under international law in the Austrian criminal code and for the implementation of the crime of aggression in the German code of crimes against international law.
