Mr. Arie IJzerman (Moderator)

Mr Arie IJzerman has been Director of International Affairs in the Ministry of Education and Director of International Criminal Affairs in the Ministry of Justice. He has been involved in many international negotiations within the European Union and outside. As Deputy Director-General of the Administration of Law and Law Enforcement and Director of the Law Enforcement Department, he is the present Chair of the Management Board of Europol and has been the Chair of the Committee of Internal Security of the European Union.

Ms. Michèle Coninsx

Michèle Coninsx has been the President of Eurojust since May 2012, after having served as Vice-President for five years. In addition, Ms Coninsx is National Member for Belgium at Eurojust and Chair of Eurojust's Counter-Terrorism Team. Ms Coninsx is a Federal Prosecutor (Magistrat Fédéral) with more than 25 years of experience. She served for nine years as an expert in aviation security for the International Civil Aviation Organization (ICAO). Before joining Eurojust, she was a National Prosecutor in Belgium dealing with terrorism and organized crime at the country-wide level. Ms Coninsx holds the noble title of Baroness (Royal Decree of 8 July 2013).

Mr Sadiq Ahmed Al-SOUR

Mr Al-SOUR is General Prosecutor and Head of the Investigation Department of the General Prosecutor's Office in Libya. He has been in charge of prosecuting Saif Al-Islam Gaddafi, Abdallah Al-Senousi and 35 other accused of the former Gaddafi-regime. Mr Al-SOUR is also leading investigations and prosecutions concerning financial crimes committed during and after the 2011 events in Libya.

Antoine Bernard

Mr. Antoine Bernard, jurist, has been the CEO of Fédération Internationale des Droits de l'homme (FIDH) since 2010, and previously its Executive Director. Earlier a consultant with the United Nations as well as Paris 2 and Paris 10 International law research centers, he has been teaching international human rights law and international relations for the past fifteen years, currently at Sciences-Po School of International Affairs (PSIA) and Paris 2 Law Faculty. An actor in the international protection of human rights for the past twenty years, Mr. Bernard contributed to numerous international field missions. He contributes daily to bridging between local and international human rights actors. He specialized in international human rights law, international humanitarian law, and international criminal law and develops FIDH's approach to human rights defenders' protection and empowerment, individual criminal accountability for international crimes, transitional justice, transnational corporations' responsibility and strategic litigation. He has represented FIDH with law enforcement officials, such as the International Criminal Court's Prosecutor, or within the United Nations Special Representative on Business and Human Rights' Leadership Group, the Advisory Board (as its Chair from 2008-2012) of the Global Social Compliance Program. He is a member of the French National Consultative Commission on Human Rights and the Steering Committee of the World Movement for Democracy. He also litigates as a legal representative before international and regional institutions. Mr. Bernard's latest publication: International criminal justice and conflict prevention, with Sidiki Kaba, Honorary President of FIDH, Minister of Justice of Senegal, in New types of conflict prevention (coll.), Bruylant, 2014 (in French only).

Ms. Fatou Bensouda

Ms. Fatou Bensouda has been the Prosecutor of the International Criminal Court since 2012. Within this role Ms. Bensouda has published a Policy Paper on Sexual and Gender-Based Crimes to guide the Office of the Prosecutor's work in fighting impunity for sexual and gender-based crimes. Mrs.

Bensouda had previously held the position of ICC Deputy Prosecutor (Prosecutions) from 2004 and to 2012. Prior to her work at the ICC, Mrs. Bensouda worked as Legal Adviser and Trial Attorney at the International Criminal Tribunal for Rwanda (ICTR) in Arusha, Tanzania. Mrs. Bensouda holds a Master's degree in International Maritime Law and Law of The Sea and as such is the first international maritime law expert of The Gambia. Before joining the ICTR, she was General Manager of a leading commercial bank in The Gambia. Between 1987 and 2000, she was successively Senior State Counsel, Principal State Counsel, Deputy Director of Public Prosecutions, Solicitor General and Legal Secretary of the Republic, and Attorney-General and Minister of Justice.in which she served as Chief Legal Advisor to the president and Cabinet of the Republic of The Gambia. Ms. Bensouda has served as a delegate to, inter alia, United Nations conferences on crime prevention, the Organization of African Unity's Ministerial meeting on Human Rights and the Preparatory Commission for the International Criminal Court.

Mr. Herman von Hebel

Mr Herman von Hebel (The Netherlands) has been the Registrar of the International Criminal Court since March 2013. Mr von Hebel has extensive experience in the field of international human rights, international criminal law and the functioning and management of international criminal courts and tribunals. Prior to joining the ICC, he was Deputy Registrar then Registrar of the Special Tribunal for Lebanon (2009 – 2013). He also served as Deputy Registrar then Registrar of the Special Court for Sierra Leone (mid-2006 until 2009). From 2001 until 2006 he was senior legal officer at the International Criminal Tribunal for the Former Yugoslavia. Mr von Hebel began his career in the Dutch government where he worked in various capacities from 1990 until 2000 at the Ministry of Foreign Affairs and the Ministry of Justice. During that time he was part of the Dutch delegation at the negotiations of the Rome Statute, which led to the establishment of the International Criminal Court.
