its provisions in achieving the independence of the Court in practicing its jurisdiction over the crime and the desired balance between its jurisdictions and Security Council's jurisdiction in this regard, which may pose a serious challenge to the Court in assessing its impartiality and activity towards the numerous international violations which meet the elements of crime of aggression.

Bringing persons who are conclusively proven to be the perpetrators of the most serious crime against humanity before the bar of justice after having undergone accurate and just investigations and punishing them with the deterrent punishment in the context of respect for the sovereignty of the states over their territory and nationals, pursuant to the principles of integrity between the jurisdiction of the International Criminal Court and the jurisdiction of the States. This will probably lead to achieving more progress towards the realization of international peace and security, a matter that requires us to continue the tireless efforts in developing and supporting the provisions of the Rome Statute of the International Criminal Court and to co-operate effectively with it in order to extend the Court's control over all violations that take place by breaking the provisions and principles of International Human Law, whose role has become greater under the skirmishes, tensions and the state of no peace that a number of regions of the world are going through.

I avail myself of this opportunity to refer to Kampala conference resolution on the retention of Article (124) of the Rome Statute which guarantees, from our vision the wider spread of the Statute and gives a char ce to the states that have not acceded yet to assess their national needs and their possible political



harmony that this article provides upon their accession to the Rome Statute of the International Criminal Court.

In this regard... we are concerned to confirm the Kuwait serious pursuit of accession to the Rome Statute of the International Criminal Court, although it has not ratified the Rome Statute until now, but its trust in the importance of this Court is great and stable. Kuwait is keen on its ti eless pursuit and effective participation in the different activities of the Court as an observer.

Finally, I renew to the assembly of the States Parties and its secretariat general the State of Kuwait's esteem and consideration for its tireless efforts in guaranteeing the protection and respect for the rules of the International Human Law, human rights and his fundamental freedoms, and for the building of an international community dominated by justice and rule of law for the attainment of the goals and objectives of the Charter of the United Nations.
