## **Statement of Qualifications**

The Government of the Republic of Bulgaria has decided to nominate Prof. Dr. Ekaterina Trendafilova to be elected member of the Board of Directors of the Trust Fund for Victims of the International Criminal Court. The decision of the Government is justified by the high qualifications of Dr. Trendafilova.

Prof. Dr. Trendafilova has served nine years mandate as a Judge of the International Criminal Court which ended on 10 March 2015. Throughout her term of office she has established a reputation of a highly competent Judge dedicated to the mission of the International Criminal Court. She left a valuable legacy in the practices and jurisprudence of the Court. Prof. Dr. Trendafilova has performed judicial duties at different stages of the proceedings in almost all situations and cases before the Court. Prof. Dr. Trendafilova has been a participant in the International Visitor Leadership Program hosted by the US Department of State.

At home, Prof. Dr. Trendafilova is well known for her deep involvement in and contribution to the reform of the criminal justice system and the protection of human rights. She has provided expertise to the Parliament of Bulgaria and to the Ministry of Justice, as well as to the Bulgarian judiciary. Prof. Dr. Trendafilova has actively worked with NGOs on a number of projects concerning the judicial field and human rights standards.

Prof. Dr. Trendafilova is a renowned scholar with publications in Bulgaria and in the USA, France, Italy, Brazil, Germany, Colombia, Croatia, The Netherlands. She has been granted Alexander von Humboldt and Fulbright scholarships. Ekaterina Trendafilova is a prominent member and president of a number of legal associations. Her professional qualifications and valuable contributions have been acknowledged by the awards granted by the Ministry of Foreign Affairs, Ministry of Justice, the Union of Bulgarian Jurists, the publishing houses of Bulgaria.

Prof. Dr. Ekaterina Trendafilova is a person of highest integrity, expertise, professionalism and commitment to the values and the mission of the International Criminal Court and to the victims of the atrocious crimes under its jurisdiction.
